












REFERRAL PATHWAY FOR Mental Health & Psychosocial Support (MHPSS) for Gender-Based Violence and Child Protection IN MALAWI

Telling Someone and Seeking Help (Disclosure)



Immediate Response

- Allay anxiety by reassuring the client that it is normal for someone to feel the way s/he feels and that something can be done to change her/ his situation for the better.
- Provide a safe, caring environment and respect the confidentiality, dignity and wishes of the client. If it is a recent incident (i.e. last week) the affected person could benefit from Psychological First Aid.
- Provide reliable and comprehensive information on the available services and support to affected individuals (this referral pathway), informing them on how to deal with the stress and risks/limitations of accessing services.

- <u>If agreed and requested by affected individual</u> (i.e. obtain informed consent)¹ and make a referral.
- In the case of a child, take into consideration their views in line with their age/ developmental stage. When family/guardians make a decision on behalf of the child, ensure the <u>best interests</u> of the child is the main consideration.
- Accompany the individual to assist him/her in accessing services.²
- For victims/survivors of sexual violence, prioritize immediate (within 72 hours) access to medical care.³

¹ The person giving informed consent, either for themselves or for others (e.g., their young child), must be competent to make the decision, participate voluntarily, have received full information and comprehended it, and understood the implications of agreeing to the service.

² Both adult and child clients should be given the opportunity to select the person to accompany him/her and in the case of confirmed COVID-19, the person selected for accompaniment should be provided with information on all the preventive measures and possible risks. His or her consent to accompany the client should be sought.

³ At a first instance is important to make referral immediately to medical care, but psychological support should be also made available for these cases.
